2. SACAA approved Flight Manual Supplement, Doc No. FMS-ST3400-HS125-004, Revision 4, dated August 7, 2013 or later SACAA approved revision is required.
3. SACAA approved Instructions for Continued Airworthiness ICA-ST34R-HS125-004, Revision 4 dated August 7, 2013 or later SACAA approved revision.
4. This STC approval does not include new installation of an antenna; separate STC approval should be obtained if a new antenna will be installed.
5. This approval should not be extended to aircraft of these models on which other previously approved modifications are incorporated unless it is determined that the relationship between this change and any other previously approved modification, including changes in type design, will introduce no adverse effect upon the airworthiness of that aircraft.
6. If the holder agrees to permit another person to use this certificate to alter the product, the holder shall give the other person written evidence of that permission

This Certificate and the Supporting Data, which is the basis for approval, shall remain in effect until Surrendered, Suspended, Revoked, or a Termination date is otherwise established by the Director of Civil Aviation.

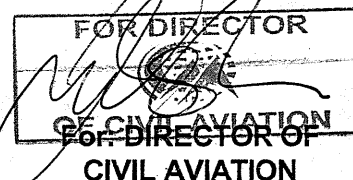
